The Internal Revenue Service (IRS) has notified us that the taxpayer identification number (TIN) on your account with us does not match their records. Enclosed is Form W-9 "Request for Taxpayer Identification Number" for you to complete, and return in the envelope enclosed. Please follow the instructions to complete the form. By doing this we will be able to correct your account records and you will avoid penalty.

If you are an individual and you have never obtained a social security number (SSN) or you have lost your card (and do not know your number), contact your local SSA office to obtain an original or replacement social security card. If you already have a social security card, please compare the SSN and name on your card to the TIN and name on this notice.

For non-individuals (trusts, estates, partnerships and similar entities) the TIN is the Employer Identification Number (EIN) issued by the IRS. The EIN on your account may be incorrect because it does not contain the number of the actual owner of the account.

A sole proprietor must furnish his/her individual name and his/her SSN or EIN for the sole proprietorship. The sole proprietor may also furnish the business name of the sole proprietorship, provided his/her individual name is listed first.
